

Bilt Card Neighborhood Parking Offer Terms

This promotional offer (“Promotion”) is open to eligible cardholders of Bilt Blue, Bilt Obsidian, or Bilt Palladium credit cards issued by Column N.A. (each a “Bilt Card”) who receive an email invitation from Bilt (the “Promotional Email”). To be eligible, you must be the Primary Cardholder of a Bilt Card account in good standing as defined by the terms of your Bilt Card cardholder agreement (“Cardholder Agreement”). You must also have a rewards account in good standing with Bilt Rewards (“Bilt”). Terms not otherwise defined in these Bilt Card Neighborhood Parking Offer Terms have the meanings assigned to them in the [Bilt Rewards Card Offer Terms](#).

This Promotion is incorporated into and forms part of your [Bilt Rewards Terms & Conditions](#). These terms are (1) solely between Bilt and the cardholder, and not between Column N.A. and the cardholder, and (2) supplemental to but separate from the Cardholder Agreement.

This Promotion is available from February 26th, 2026 through December 31st, 2026 (“Promotional Period”). Your individual promotional window begins at 12:00 am ET on the date that the Promotional Email was recorded as delivered to the email address we have on file for your Bilt Rewards account (“Delivery Date”) and expires at 11:59 pm ET on the sixth (6th) calendar day following the Delivery Date (“Promotional Window”). The Delivery Date is determined by Bilt’s email delivery records and is not affected by the date on which you open, read or otherwise acknowledge receipt of the Promotional Email. You are responsible for ensuring that your email settings allow for the receipt of the Promotional Email. Neither Bilt nor Column N.A. is responsible for non-delivery caused by third-party email filtering services or mailbox provider settings.

You can earn bonus points when you make Qualifying Purchases (defined below) with your Bilt Card during the Promotional Period that post to your Bilt Card account during the Promotional Window and meet the conditions set forth in these Bilt Card Neighborhood Parking Offer Terms.

Qualifying Purchase: A “Qualifying Purchase” is a net Purchase (Purchases minus returns, credits, and other adjustments) that posts to your Bilt Card account during the Promotional Window for drive-up parking at participating Metropolis parking locations (available in the Bilt app and here <https://www.bilt.com/rewards/parking>) (“Metropolis Parking Locations”). To qualify, you must (1) successfully link your Bilt Rewards and Metropolis accounts and (2) use your Bilt Card as the payment method for the Metropolis Parking Location. The phone number on your Bilt Rewards and Metropolis accounts must match exactly to successfully link your accounts. You are responsible for ensuring that you satisfy the qualification criteria in these terms, including that your Bilt Rewards and Metropolis accounts are successfully linked. Neither Bilt nor Column N.A. is responsible for your ability to satisfy the qualification criteria or for any failure to do so in connection with this Promotion. A purchase “posts” on the date it is processed and reflected in your Bilt Card account balance, which may differ from the date the Purchase was made. Qualifying Purchases will earn an additional 5X Bilt Points (“Bonus Points”) per \$1 spent. Drive-up parking at participating Metropolis Parking Locations to which you choose to apply a

promotional financing offer, transactions to purchase gift cards, and transactions made towards interest or fees of any kind are not eligible and will not earn Bonus Points under this Promotion.

Exclusions: Purchases at any Metropolis parking facility other than a qualifying Metropolis Parking Location do not qualify for Bonus Points under this Promotion, including (i) official on-premise aviation/airport; (ii) official on-premise events; (iii) municipal/government; and (iv) hospital/medical facilities. This Promotion is valid for continental U.S. parking only and excludes U.S. territories. If any portion of a Purchase is for ancillary charges—including, but not limited to, administrative fees, penalties or fines—such portion of such purchase will not earn Bonus Points under this Promotion. Purchases made with payment methods other than your Bilt Card are not eligible and will not earn Bonus Points under this Promotion.

The maximum Bonus Points you can earn with this Promotion is 1,000 Bonus Points, regardless of how much you spend. It may take up to seven (7) business days after the transaction clears for Bonus Points earned through this Promotion to post to your Bilt Rewards account. Purchases will be subject to the [Bilt Parking Terms and Conditions](#).

You may not receive the Bonus Points if Bilt Rewards receives inaccurate information or is otherwise unable to identify your purchase as a Qualifying Purchase under the Promotion. Should you receive bonus points on an ineligible purchase, Bilt may deduct those points at its discretion.
