

Bilt Travel Portal Statement Credit Promotion – Terms & Conditions

Promotion Period: Offer valid for travel bookings made in the Bilt Travel Portal between now and November 17, 2025. Bilt reserves the right to modify or terminate this promotion at any time without prior notice. Any modifications or terminations will not affect bookings made prior to the effective date of such change.

Eligibility: This offer is available only to eligible Bilt Members who receive this promotional communication directly from Bilt and who make a qualifying booking through the Bilt Travel Portal during the promotion period. Offer is limited to one (1) statement credit per member.

How It Works:

1. Make a booking in the Bilt Travel Portal by November 17, 2025 with a total booking amount at least equal to the promotional credit amount.
2. Bilt will track your booking through completion of your travel.
3. Once your travel is complete, Bilt will apply a statement credit automatically to the card you paid with.
4. Please allow up to 30 days after completion of travel for the statement credit to appear on your account. The timing of credit application may vary by issuer. Timing may vary based on your card issuer's processing schedule. Bilt does not control and is not responsible for your issuer's timing, allocation or handling of the statement credit and Bilt is not responsible for delays once the credit is transmitted to your issuer.

Refunds, Cancellations, and Adjustments: If a booking is canceled, modified, refunded (in full or in part), or otherwise not completed as booked, the statement credit will not be issued or may be reversed or reclaimed.

Bilt reserves the right, in its sole discretion, to reclaim the credited amount from the member's account, future rewards balance, or by charging the card used for payment. Any charge to a payment card will comply with applicable card network rules and consumer protection laws, and members will be provided notice before such action.

Credit Application: The statement credit will be issued through the card network and applied by the issuer of the customer's card. The application of the credit is subject to the issuer's own policies and procedures, including how credits are handled if the account has no outstanding balance or if the credit exceeds the remaining balance. Bilt is not responsible for how or when your issuer applies the credit to your account.

Fraud, Abuse, and Misuse: Bilt reserves the right, in its sole discretion and acting in good faith, to determine whether participation in this promotion is abusive, fraudulent, or otherwise inconsistent with the Bilt Rewards Terms & Conditions.
